I. General

The Town of Lima (Town) has received public interest in establishing a water district, along portions of Poplar Hill Road, Woodruff Road, Briggs Road, Doran Road, Jenks Road, Chase Road, Pond Road, Gleason Road, York Street, Corby Road, Dalton Road, Heath Markham Road, and Egan Road as shown in Figure 1 at the end of this report.

A water district is a special use district required by Town Law where a specific area of the town receives a specific benefit. The cost for receiving this benefit is borne solely by the property owners in that specific area.

The purpose of this project is to provide a safe and reliable potable water supply and fire protection to the properties in the proposed Town of Lima Water District No. 5 (Water District).

II. Project Planning Area

A. Location

The proposed Water District will include a total of approximately 86,810 linear feet of 8-inch and 12-inch water main, hydrant, gate valves, and water services. The water main will be installed along portions of Poplar Hill Road, Woodruff Road, Briggs Road, Doran Road, Jenks Road, Chase Road, Pond Road, Gleason Road, York Street, Corby Road, Dalton Road, Heath Markham Road, and Egan Road and will provide water supply approximately 201 residential and commercial properties. Note, there are an additional 47 properties that will not be provided with service, as they are vacant.

B. Environmental Resources Present

There are farmlands present in the project area. All construction will be taking place in existing road right-of-way or easements, and proper construction mitigation and restoration efforts will be implemented based on standard practices common to the industry.

There are Federally and State regulated wetlands, but they will not be impacted by the project as the water main will either be installed in the road right-of-way or directional drilled. In addition, several Class C streams will be crossed as part of the project either under a cross culvert or drilled.

There are no known endangered species in the project area, but the area does have the potential for Northern Long-eared bats. Tree removal, if any, will be limited between April and September.

Historical properties and cultural resources will be further evaluated during design when the precise location of the proposed main can be identified. Construction will not proceed until SHPO is consulted and their approval is obtained.

C. Population Trends

According to the United States Census, the Town had a population of 4,305 in 2010 and 4,175 in 2020, representing a 3% decrease.

D. Community Engagement

The Town sent out a public survey form to the almost every property in the Town without public water in 2021, receiving 242 individual responses. Approximately 71% of the surveys indicated a desire for public water at an annual cost ranging between \$900 and \$1,500 per year. 56% of the respondents indicated they were not satisfied with the quantity of their private water supply and 54% were concerned with the safety.

Based on the 2021 survey a town wide water district was proposed but failed to reach the required number of signatures on the petition. However, the petition results did indicate significant pockets of interest in select areas.

In 2024 the Livingston County Water & Sewer Authority (LCWSA) was engaged to assist the Town with the process and the LCWSA implemented the following public engagement activities between the months of April and July 2024:

- The creation of a public website with project related information such as map of proposed scenarios, spreadsheet of cost summaries, general water district Q&A sheet and an electronic format for the public to submit questions and comments.
- The publication of an on-line public survey to receive interest from the public regarding a potential water project.
- Letters were sent to 695 property owners in the Town that currently do not have water, encouraging them to review the website and complete the public survey. Letters were sent on April 26th and then again on June 4th. The LCWSA mailed out surveys to residents/property owners that requested hard copy surveys. The survey was closed on July 30th.
- The LCWSA received over 291 responses to the survey.
- Public meetings were conducted on May 29th and June 15th to provide an overview of potential water projects and answer questions from residents/property owners. Both public meetings included a brief presentation of potential district scenarios followed by individual conversations with the public regarding specific interests and concerns relating to their property. Also, the public had access to review large printouts of potential scenario maps and were encouraged to mark and comment on the maps with specific thoughts. There was also a comment box for anyone to submit comments. Both meetings were well attended.

III. Existing Facilities

A. Location Map

Refer to the project location map on Figure No. 1 at the end of this report, which depicts the existing water system within the Town and Village of Lima.

B. Existing Water Supply

The entire area of the proposed water district is presently served by private wells. The Town has received several complaints about the quality and quantity of the water in the area. Residents in this area have experienced the following problems based on actual survey results:

- *We have been hauling water from West Bloomfield for years now, if people knew about the quality of Hemlock water they would not hesitate to sign up.*
- *I am on my third water treatment system. first was a DIY system done by person who built the home, second was Culligan - I had their top system and it kept plugging up and flooding due to iron. Now aquaclear system which handles most of iron but now I have sulfur. have spent about 25K so far and have to spend another 4K to add more equipment for sulfur.*
- *We just moved in a few weeks ago. We got the water tested for bacteria and nitrates/nitrites and we have Coliform in our well. This was concerning because we have a one year old. We got our water inspected by Culligan and our iron content was at the highest they can measure and our TDS was high. Our well is also salty. Basically our well water stinks and I just wanted to say as a new member of the community I fully support the provision of public water to our road!*
- *Fire protection and less fixture scrubbing to remove the iron stains are pluses!*

C. Water Demands

The existing demands for the proposed service area are as follows:

Single Family Homes

Average Day 27,123 gpd
(Based on 198 EDU's, each using 50,000 gallons per year)

Commercial

Average Day 2,534 gpd
(Equates to 18.5 Single Family EDU's)

The future demands for the proposed service area will utilize a 1% increase per year. This increase considers population projections and the land use of the area.

IV. Need for Project

A. Health and Safety

The proposed water main will provide safe potable water to the residents of the proposed Water District No. 5 and will eliminate the public health risks associated with the quality and quantity of ground water in the area.

B. System O & M

A water distribution network will replace highly expensive individual water treatment units; this will reduce the operation and maintenance costs borne by the residents at this time. The Town will contract with the LCWSA to provide retail service and operation and maintenance of the proposed service area.

C. Growth

While economic development is viewed as a project benefit, balancing economic development and land protection is necessary, critical, and has been considered for this project. Agriculture is important to the Town, functioning as a part of the Town's economic base as well as being the foundation for the rural character that the Town wishes to maintain.

The Town intends to follow NYS Department of Agriculture & Markets guidelines by passing a lateral restriction policy, which will not permit the Town to provide a lateral to any currently vacant farmland in an Agricultural District. Thus, there are no anticipated long-term impacts to the properties in the Agricultural District as a result of the proposed action including no change in use of agricultural/residential lands within the Agricultural District.

In addition, many properties owners in the Town participate in the Livingston County agricultural assessment program, which encourages continued agricultural production by reducing taxes for eligible landowners. The parcels participating in the program are shown on the map in Appendix A, which also depicts properties that have elected to permit the purchase of development rights (PDR) on individual farms.

V. Alternatives Considered

A. Description

1. Alternative 1 – Null Alternative

Estimated Capital Cost: \$ 0

This alternative proposes to “do nothing”. The residents of the proposed Water District would continue using their existing well treatment systems, some whose annual costs exceed \$1,500. Costs for the purchase of bottled water and off-site laundry services add an estimated \$500 to \$1,000 per year to the cost of a private well.

2. Alternative 2 – New Water Distribution System

Estimated Capital Cost: \$15,260,000

The proposed action includes the installation of approximately 86,810 linear feet of 8-inch and 12-inch water main to provide potable water and fire service. This includes approximately the replacement of 3,900 linear feet of water main to improve system hydraulics and 8,680 linear feet of transmission main.

Fire hydrants will be located every 700 feet along the proposed water main. Gate valves will be installed every 1,200 feet and at every branch connection.

The project will include the construction of a booster pump station to serve the southeast portion of the Town, as the pressures and fire flows from the Village of Lima water tank will not be adequate. The pump station will provide increased pressures for domestic usage and increased flow for fire protection.

Water services (long and short side) will be provided for all properties requiring a service, from the water main to the property line.

The estimated costs for Alternative 2 are detailed in Appendix C.

B. Design Criteria

The proposed Water District has been designed to provide safe potable water and fire protection to the residents within the proposed service area.

C. Map

The proposed Water District map is included in Appendix B.

D. Environmental Impacts

There are no anticipated negative environmental impacts associated with the project. However, an environmental review will be done for the project. All construction will be done in existing road Right-of-Ways or easements, and proper construction mitigation and restoration efforts will be implemented.

E. Advantages/Disadvantages

Although there are significant costs associated with Alternative 2, it is the most viable alternative as it is consistent with the goals and meets the needs of the proposed Water District. The advantages of Alternative 2 are as follows:

1. It will eliminate the ongoing health risks associated with the quality and quantity of ground water in the area.
2. Combined with other proposed water districts, it will be a step towards creating redundancy in the existing system increasing the reliability of potable water supply and fire flow.

VI. Recommended Alternative

The recommended alternative is Alternative 2 - New Distribution System for the proposed Water District No. 5.

A. Project Design

1. Water Supply

The majority of proposed Water District will receive water from the LCWSA through a connect to existing main in the Town of Livonia. A small portion of the Water District will receive water through a direct connection to the City of Rochester conduits, this includes properties along York Street and Corby Road.

2. Treatment

All the water for the proposed Water District will be obtained from the City of Rochester Water Treatment Plant located on Hemlock Lake. The treated water meets all the state and federal drinking water standards.

3. Storage

The primary water storage will be provided by the existing Village of Lima elevated water tank, central to the Town. In addition, storage will also be provided by the proposed LCWSA Shelly Road Upper Tank, being constructed in 2025 in the Town of Livonia.

4. Pumping Stations

The project will include the construction of a booster pump station to serve the southeast portion of the Town, as the pressures and fire flows from the Village of Lima water tank will not be adequate. The pump station will provide increased pressures for domestic usage and increased flow for fire protection.

5. Distribution Layout

The proposed distribution system is shown in Figure 1 at the end of this report, which does include the replacement of select water mains in the Town and Village of Livonia.

6. Water Services

The portion of the water service from the right-of-way to the main line will be the responsibility of the Water District. This will include water meter pits for properties with homes or businesses over 150 feet from the roadway. The portion from the right-of-way to the home will be the responsibility of the homeowner.

B. Proposed Water District Costs

The residents of the proposed Water District will assume the cost for the project. The estimated project unit costs are based on financing through USDA Rural Development at a 2.875% interest rate for a 38-year term, along with projected grant funding from the USDA Rural Development and New York State Environmental Facilities Corporation.

The estimated average annual water cost was estimated based on a retail rate of \$5 per 1,000 gallons from the LCWSA and an average usage of 50,000 gallons per unit per year, along with a base charge of \$40 per quarter.

2. Equivalent Dwelling Units

Unit definition

- Any facility will be considered as a minimum of one (1) unit.
- Each single-family residential dwelling shall be considered to be one (1) unit. Included in this category will be single family houses and mobile homes.
- Multiple single-family dwellings on the same parcel of land will each be considered an individual unit.
- Vacant developable land not within the certified agricultural district will be assessed one-half (0.5) of a unit.
- Vacant undevelopable land not within the certified agricultural district will be assessed one-tenth (0.1) of a unit.
- Non-residential, commercial, and industrial facilities will be assigned an equivalent number of units based on usage.

Appendix D includes a table that lists every property within the proposed Water District along with the estimated number of units associated with each parcel. It should be noted that the parcel associated with tax ID 58.-1-7.1 will be assigned 2 units at the request of the property owner due to future plans for new home construction.

3. Other One Time Costs

LCWSA Fee including Meter	\$650
Service Line	\$30/LF (\$3,000 Average)
Well Separation/ Plumbing Modifications	\$500

VII. Miscellaneous Information

A. Options for property owner’s well

1. Abandon the well.
2. Keep well but separate it from public water plumbing.
3. Keep well and install backflow prevention.

B. Service Line Information

1. A service line will be installed to all residences, from the water main to the road Right-of-Way, for connection to the public water system.

C. Optional Water District Enhancements with Remaining Funds

1. Upsize water main diameters to allow for future growth of the water system and maintain above average fire flows.

- 2. Extend water mains to the Water District boundaries and through road intersections.
- 3. Reimburse the costs of the any fees for the residents of the Water District.

D. Project Schedule

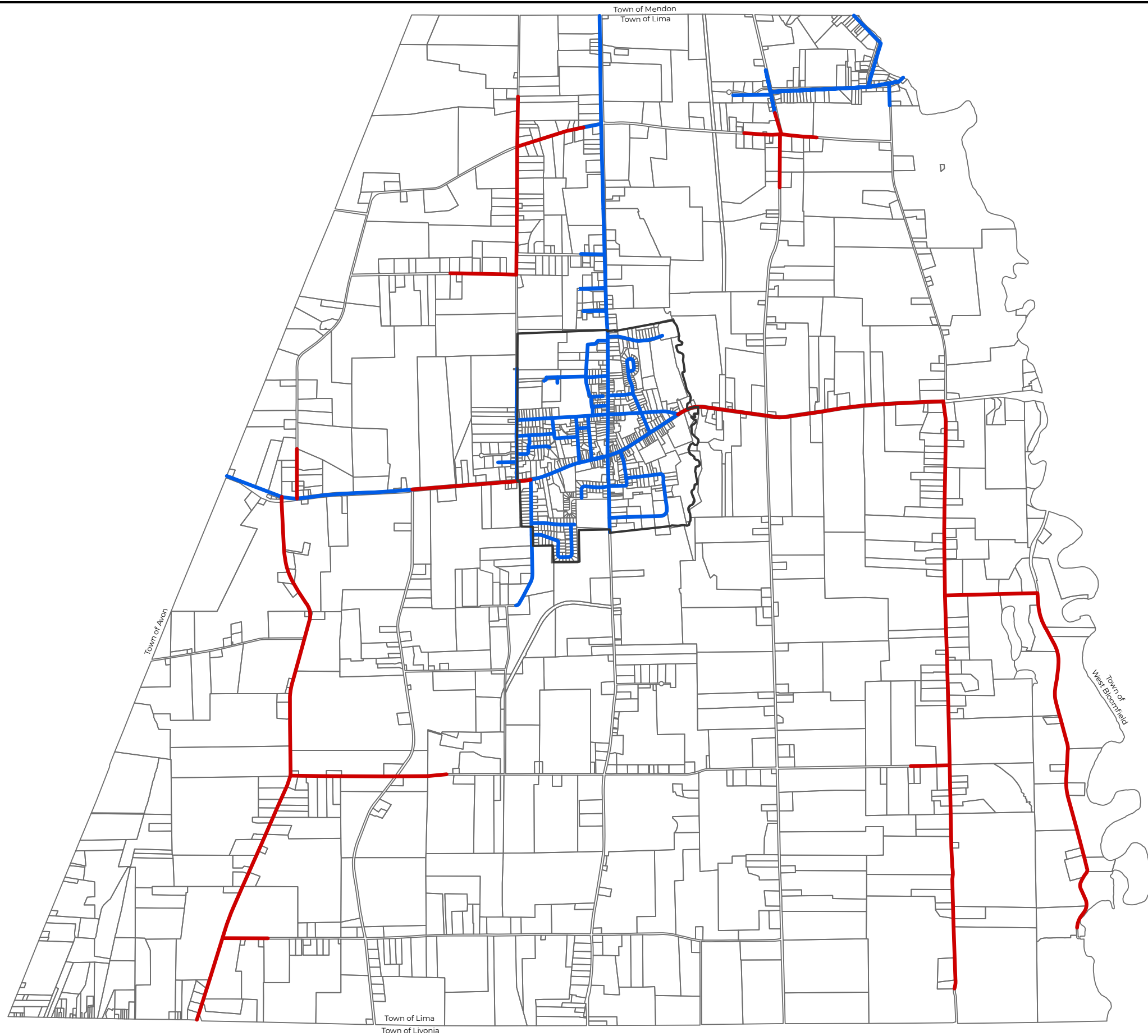
The project is anticipated to take place in several phases, with an overall schedule as follows:

VIII. Conclusions

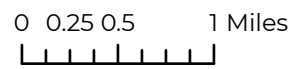









Agricultural Exemption & PDR Map

Livingston County



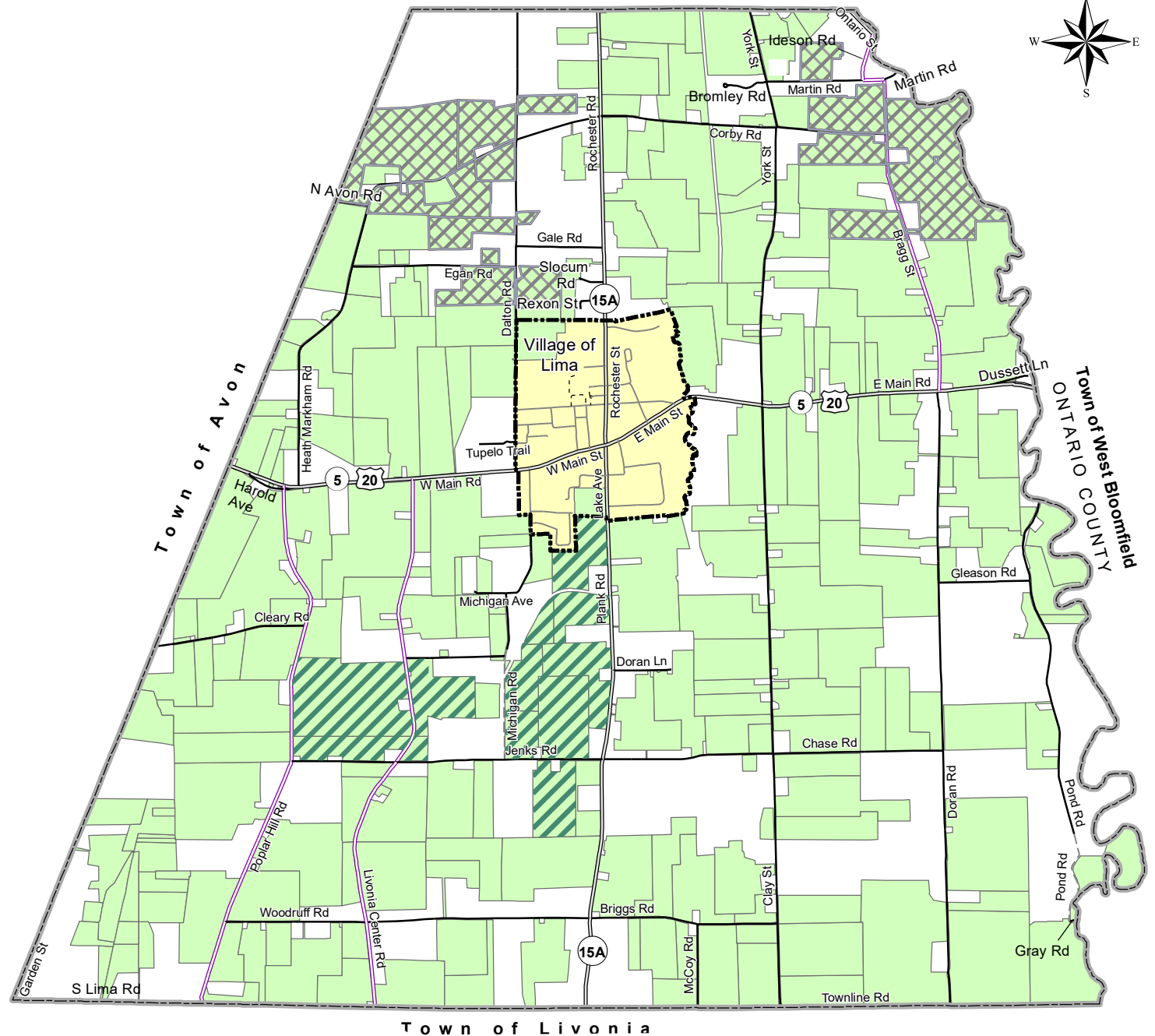

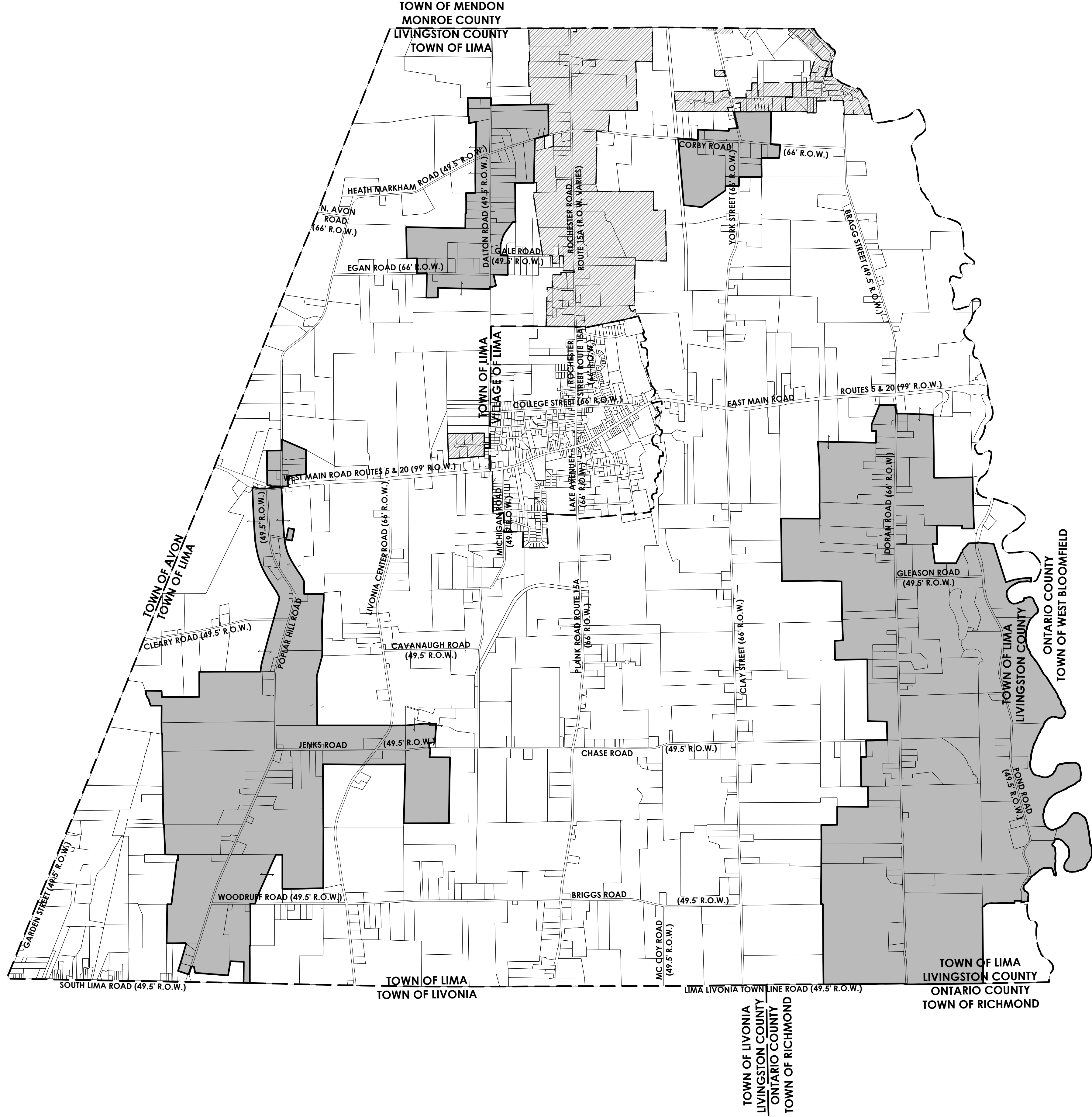
